

## **Information provided pursuant to articles 13-14 of the GDPR 2016/679 (General Data Protection Regulation)**

Dear Sir / Madam,

pursuant to art. 13 of EU Regulation 2016/679 and in relation to the information that will come into possession, for the purposes of protection of persons and other subjects regarding the processing of personal data, we inform you as follows:

### **6. Rights of the interested party**

At any time, you can exercise, pursuant to articles 15 to 22 of EU Regulation no. 2016/679, the right to:

- a) ask for confirmation of the existence or otherwise of their personal data;
- b) obtain information about the purposes of the processing, the categories of personal data, the recipients or the categories of recipients to whom the personal data have been or will be communicated and, when possible, the retention period;
- c) obtain the rectification and cancellation of data;
- d) obtain the limitation of the processing;
- e) obtain data portability, i.e. receive them from a data controller, in a structured, commonly used format e readable by an automatic device, and transmit them to another data controller without hindrance;
- f) oppose the processing at any time and also in the case of processing for direct marketing purposes;
- g) oppose an automated decision-making process relating to physical persons, including profiling.
- h) ask the data controller to access personal data and to correct or delete them or limit them of the treatment that concern him or to oppose their treatment, in addition to the right to data portability;
- i) withdraw consent at any time without prejudice to the lawfulness of the processing based on the consent given before revocation;
